

Bread for the World Institute has led a coalition around food aid reform focused on making U.S. international food aid policy efficient, effective, and focused on reaching those who need the aid. Working in partnership with the World Food Program U.S.A., Catholic Relief Services, and ONE, Bread for the World Institute successfully urged the House Transportation and Infrastructure Committee to drop harmful language in a Defense Authorization amendment that changed non-availability determinations and tonnage requirements for food aid, which would have reduced food aid at this crucial time.
