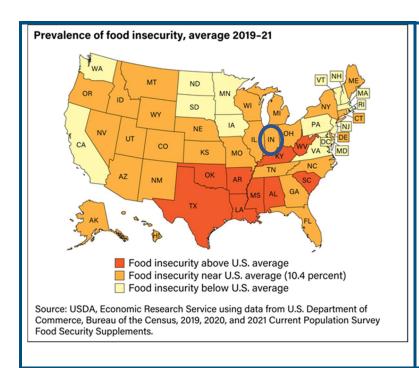


# Indiana

## A Hunger and Poverty Snapshot

#### Between 2019-2021:

- Food insecurity in Indiana averaged 9.7%.<sup>1</sup>
- Indiana's food insecurity rate was 7% lower than the national average of 10.4%.<sup>2</sup>
- The official poverty rate (which does not account for income from safety-net and tax-support programs such as SNAP, EITC, and others) in the state averaged 10.9%.<sup>3</sup>
- But using the Supplemental Poverty Measure (which does include safety-net and tax-support income), the
  poverty rate falls to 7.4%.<sup>4</sup> In other words, these programs reduced the poverty rate in Indiana by 32%
  and the number of people living in poverty by 233,000.<sup>5</sup>
- SNAP, alone, lifted 141,000 people above the poverty line in Indiana, including 66,000 children, per year between 2013 and 2017, on average. <sup>6</sup>



#### Nutrition and Health

Diabetes and other diet-related health costs in Indiana were estimated to be \$6.5 billion<sup>7</sup> in 2017.

11.8% of the adult population in Indiana has been diagnosed with diabetes in 2020.8 This includes:

- 23.5% of seniors.
- 14.3% of Black adults.
- 20.5% of adults with incomes of less than \$25,000.

Every year an estimated 40,155 adults<sup>9</sup> in Indiana are diagnosed with diabetes.

Only 13.0% of adults in the state are meeting recommended fruit intake and 10.5% recommended vegetable intake. 10

Why Bread for the World is Focused on the Farm Bill

The Farm bill is scheduled to be reauthorized in 2023. No legislation has more impact than a farm bill on the US food system and the nation's ability to provide healthy food at affordable prices to everyone.

Bread for the World's farm bill priorities include a focus on nutrition, equity, and sustainability. We believe Indiana has a lot to gain from a farm bill legislated with these priorities in mind.

Nutrition

Bread for the World supports strengthening SNAP in Indiana.

Not only is SNAP the flagship food security and nutrition program, it is indispensable to better health outcomes and economic prosperity.

In 2021, 9% of Indiana residents were helped by SNAP.<sup>11</sup>

- Roughly 231,200 workers in Indiana live in households that participated in SNAP in 2021.<sup>12</sup>
- SNAP helps 1 in 13 workers in Indiana put food on the table.<sup>13</sup>
- 74% of SNAP participants were in families with children, and 33% in families with members who are older adults or are disabled.<sup>14</sup>
- 75% of all SNAP-eligible people in Indiana participate in the program.<sup>15</sup>

Equity

Bread for the World supports farm policies that promote a more equitable food system in Indiana.

The Indiana population is 77.5% white. According to the most recent Census of Agriculture, 99% of farmers and ranchers (producers) in Indiana are white and occupy 99% of all farmland.<sup>16</sup>

- Black producers represent <1% and occupy <1% of farmland.
- Hispanic producers represent <1% and occupy <1% of farmland.</li>
- Indigenous producers represent <1% and occupy <1% of farmland.</li>

Sustainability

Bread for the World is committed to eradicating food insecurity by building a more sustainable food system in Indiana.

Reducing unnecessary food waste is one way to build a more sustainable food system.

In 2019, 1.6 million tons<sup>17</sup> of surplus food in Indiana went to waste instead of reaching those who needed it, an amount equal to:

- 2.58 billion meals unsold or uneaten.<sup>18</sup>
- \$8.28 billion in lost sales. 19
- Annual CO2 emissions produced by 1,344,528 gasoline-powered cars.<sup>20</sup>,<sup>21</sup>
